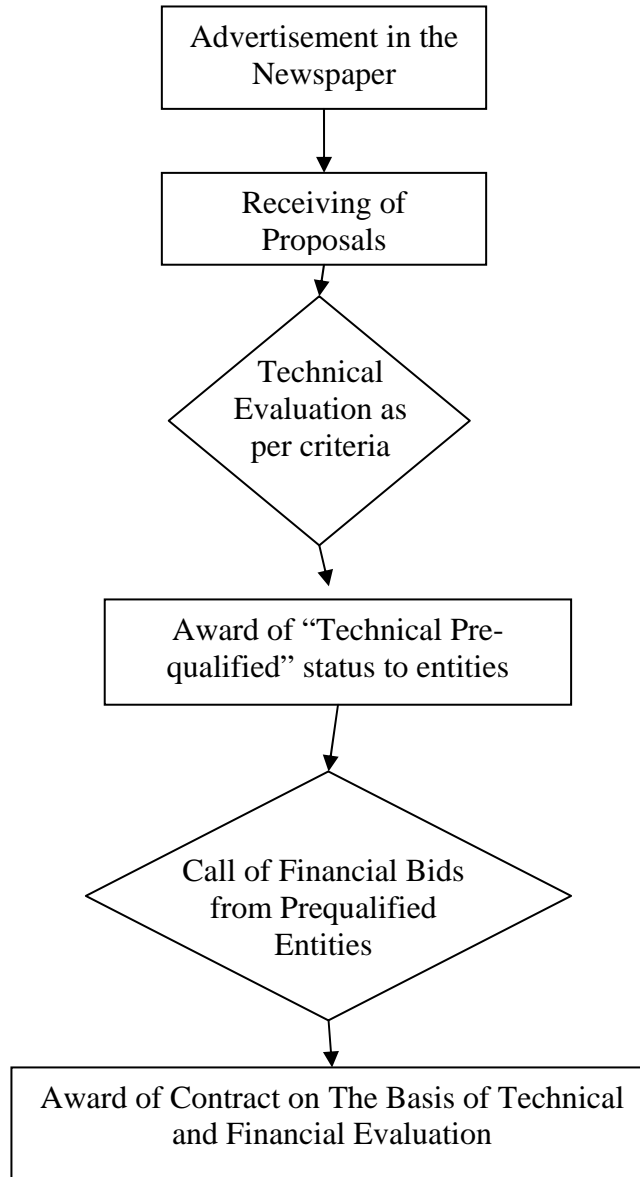

Any documents received after the closing date for submission of proposals shall not be entertained.
- ii) The firm / organization must have valid National Tax Number (NTN) and Sales Tax Number (if applicable).

- iv) Technical prequalification will be on the basis of criteria defined in Pre-Qualification documents.
