

## LAHORE EXPO CENTRE, JOHAR TOWN, LAHORE

### **TENDER NOTICE FOR INTERIOR FURNISHING WORKS**

1. Expo Lahore (Pvt.) Limited (ELPL) invites bids in a prescribed form along with three envelopes (Envelope-I for bid security, Envelope-II for qualification proposal and Envelope-III for bidding document) from leading well-reputed national firms for supply and installation of state-of-the-art Interior Furnishing Works divided in six (06) lots, namely, Supply & Installation of Planters, Blinds, Carpets & Rugs, Signology, Art Work and Kitchen Equipment for Lahore Expo Centre. It is a world-class exhibition centre, at present under-construction at Johar Town Lahore, and spread over an area of 400 kanals comprising four large exhibition halls, a convention centre and ancillary facilities.
2. The bidding documents can be purchased from the office of the undersigned on or after June 01, 2007 on payment of Rs.5000/- (non-refundable) through demand draft/pay order in the favor of Expo Lahore (Pvt.) Limited. Bids shall be accompanied by a bid security of an amount listed hereunder in favor of Expo Lahore (Pvt.) Limited for the lots against which bid proposals are being offered on the format given in the bidding documents:

3. The bidders may bid for one or more lots. Bidders wishing to offer discounts in case they are awarded more than one lot, shall be allowed to do so, provided those discounts are included in the form of bid or submitted in writing before bid submission.
4. All the bidders shall be post-qualified. Only those bidders shall offer the bids who can furnish documentary evidence of the following requirements:
  - The manufacturer of the offered goods have at least three (3) years experience in manufacturing similar type of goods for a respective lot.
  - The bidder should have at least three (3) years of experience in supply of similar items of the type specified in the Schedule of Requirement for a certain lot. List of major works of similar nature and magnitude executed during the last 3 years, giving names of the clients with supporting documents should be submitted.
  - The bidder should be registered with Income Tax and Sales Tax Departments.
  - The bidders should have successfully supplied goods of a similar nature against contract of aggregate value not less than the total bid amount quoted, against one lot or a combination of lots, in any (1) of the last (3) financial years. Documentary evidence must accompany the bid in the format given in bidding documents.
5. Pre-bid meeting shall be held on Monday, June 11, 2007 at 10:30 A.M at office of the undersigned.
6. Bids complete in all respects shall be received latest by Monday, June 25, 2007 at 11: 30 A.M and the qualification part (Envelope-II) with the Bid security part (Envelope-I) shall be opened on

the same date at 12:00 P.M in the Conference Room of ELPL in the presence of bidders or their representatives who may choose to be present.

7. ELPL reserves the right to reject any or all bids and to annul the bidding process without assigning any reason and without thereby incurring any liability to the affected bidders.
